1. Introduction

Tradestone Ltd (hereinafter the “**Company**”, “**We**” or “**Us**”) is a Cyprus Investment Firm (hereinafter the “**CIF**”), which is authorized and regulated by the Cyprus Securities and Exchange Commission (hereinafter the ‘**CySEC**’) with License No. 331/17.

The Company is subject to the provisions of the Investment Services and Activities and Regulated Markets Law of 2017, Law 87(I)/2017 (hereinafter the “**Law**”).

You should be aware that when you access or use our content, products and services, we may collect information from your devices using ‘cookies’.

2. What are cookies?

Cookies are small text files stored on your computer by a website you visit. They enable certain functions on the website and allow it to remember your preferences. Cookies can store data on pages where you have provided key information (e.g. when you provide a password) but only after you have been asked and consented to their use.

Cookies are not programs and cannot be executed as code or deliver viruses, instead cookies act more like a passport, which the site checks and updates whenever you visit. Cookies cannot introduce malware to your computer as the data in a cookie file remains unchanged as it travels back and forth, meaning it cannot affect how your computer operates.

Cookies may be used on some pages of the site for us to provide website users with a more customized web browsing experience; they are not used to determine the personal identity of anyone merely visiting the site.

3. Why we use cookies

Tradestone Ltd uses cookies to ensure the optimal functionality of Company’s Website and to tailor content to clients’ personal preferences. As a regulated broker, the client may rest assured that any personal information collected by the Company, through any means, will not be shared with third-parties.

The Company encourages its clients to also review the Privacy policy for more detailed information on how fbs.eu uses clients’ data.

4. How we use cookies?

We use cookies for a variety of reasons and here is an overview of some of the functions our cookies provide us with:

- to allow customers to set website preferences and tailor content accordingly
- to verify the customer’s identity and detect the country the customer is visiting from
- to determine the type of browser and device the customer is using
- to collect information about customer’s activity on the website and understand how it is being used
- to detect and prevent fraudulent use of our Website
- to track how customers arrive at the website and to track referrals
- for research and analytical purposes to see which Users interact with the Website in aggregate.

We do not under any circumstances, sell information collected via cookies.



5. Cookie types

5.1 Session cookies

These cookies are temporary cookies as they are deleted as soon as you close your browser. Session cookies are used to retain the information you provide us with as you navigate through each section of our website. You can choose to decline session cookies via your browser's privacy settings but please note that this may have a negative impact on your browsing experience and particularly if these are declined across all websites.

5.2 Performance cookies

These cookies allow us to count visits and trace sources so we can measure the usability of our site and improve the performance of our site. They help us to know which pages are the most and least popular, see how visitors move around the site and if any error messages are displayed. All the information these cookies collect is aggregated and therefore anonymous. If you do not allow these cookies we will not know when you have visited our site, and will not be able to monitor its performance

5.3 Strictly necessary cookies

These cookies are necessary for the website to function and cannot be switched on in our systems. They are usually only set in response to actions made by you which amount to a request for services, such as setting your privacy preferences, logging in or filling in forms. You can set your browser to block or alert you about these cookies, but some parts of the site will not then work. These cookies do not store any personal identifiable information.

5.4 Analytical cookies

Analytical cookies may include both temporary and more persistent cookies that we use to track how you use our website and for how long. Analytical cookies do not divulge any identifying information specific to your person but they do help us improve how we provide you with our content.

Refer to your browser's privacy settings on how you can opt-out of analytical cookies.

5.5 Functional cookies

Functional cookies record and save your choices in order to provide for a more seamless experience across our website. For example, they remember your language selection each time you visit us.

Refer to your browser's urgent privacy settings on how you can opt-out of functional cookies.

5.6 Third Party cookies

These cookies are used by third parties and mostly by social media websites like Facebook, Google+, LinkedIn, Twitter, YouTube or Live chat. Third Party cookies allow us to offer you easy ways to share our content throughout your social media and also present you with the videos we post on YouTube. Clients can disable the use of these cookies through their browser's privacy settings but this will also disable all the functions described above.

Clients may find more information about the individual cookies we use and the purpose for which we use them, in the table attached below.



6. Updates

The Company will perform a periodical review of this Document, at least once a year. The Document is in line with the Company’s operational model, and therefore in case of any changes in the operations, these will be properly reflected in this Document.
